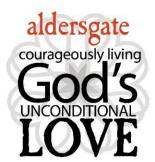
Aldersgate United Methodist Church Zoom Church Conference and Leadership Team Meeting

 - Strategic Plan Update John McRae
 - Engage Barb Roach and Beth Bachmore
 - Barb Roach reported that the Hugs and Mugs Welcome Back coffee that the Engage team sponsored for the day school families was a big success. - Connect Worship, Steve Larkin and Don McIlwain
 - Weekly worship attendance averaged 208 for the past month. There have been few problems filling volunteer slots.
 - Looking ahead to Advent and Christmas, neither Steve nor Hilary will be in town so it is important to encourage volunteer sign ups so they are clear on what is expected of them. It is recommended we begin recruiting volunteers Columbus Day weekend--October 13.

 - Everyone is settling into the fall routine!
 - Kids' Ministries has been expertly planned this fall by Lisa Lee.
 - o Adult offerings continue to expand, with a new adult SS class and two new small groups
 - We now have four adult SS classes, including a new 8-week class on Romans offered by Jeff Long– all classes will be at 9:30 am Sundays
 - We now are offering TEN adult small groups....this includes two new groups:

- 5. Church Work Operations
 - Finance Update Mark Easton (Updates on Finances, Stewardship, and Mortgage Refinance)
 - This month I am deviating slightly from providing a financial synopsis as the focal point for my report. With Jane just returning from some well-deserved vacation time, I don't yet have access to the end of month numbers. Following our September close out, I'll return to using a financial synopsis in October. In the meantime, I wanted to provide a few short updates:
 - Mortgage Refinance Planning: Thanks to the leadership of Ed Little and able support of Sean Vermillion, this effort continues. We have made contact with all of our possible target institutions, and our financial health subcommittee will be meeting to begin to evaluate and narrow this list down next week. The decision made last month by the Leadership team last month relating to parsonage #2, and ratified by the recent Church Conference, should allow us to use proceeds from a future sale of this property to significantly reduce the principal owed. Further, the forecasted positive interest rate trend should allow us to be in a favorable position to execute our refinancing prior to the February 2025 maturity date.
 - Stewardship campaign planning: Mark Husband has graciously stepped forward to lead this years' effort. We have tentatively selected a theme of "The Heart of a Servant" and established a goal of \$1M and 200 pledges. The campaign will be announced in early October and will take place in November, with four Sunday sermons and Gratitude Sunday on November 24th. As in past years, we will be asking for "Lead Commitments/Pledges" from everyone on our Leadership and Stewardship teams. This will provide a baseline that will provide an example for giving by the broader congregation.
 - 2025 Operating Budget: Under the outstanding leadership of Jill Cox, we are nearly complete with the review of your inputs and are in the process of developing a draft budget that will be reviewed at next months' Leadership Team meeting and presented to the Church Conference on October 22nd. With that said, we may still be reaching out to some of you if questions arise. Once again, many thanks for the support of all those involved.
 - Trustee Update Sean Vermillion and Ed Little (Sale of Parsonage)
 - The Shepherd Hall loan matures in February 2025. We will have to refinance the loan before then. The REFY Tean has been working with a number of banks to evaluate the best candidates. We have three good possibilities at this point. They are AUB (current loan bank), DEVCO-business part of the Foundation, and LINK Bank-with Rafael Martinez who was previously with AUB. Information has been provided to each bank including the possibility of the sale of the Anesbury parsonage. Obtaining a loan of \$1M vice a loan of \$1.8M makes a big difference in the ease of obtaining the loan and receiving a better interest rate. We have one proposal already form LINK Bank. Interest rates from LINK are in the range of 5-6%. The REFY Team is continuing to work with all the banks and will make a recommendation as to the best candidate in the next few months.

This will help the work of the mortgage team in refinancing.

Stewardship is about to hit full swing as well and we are glad to have Mark Husband heading up the team, with lots of support from Mark Easton and Jill Cox. I am looking forward to playing in the UMMen golf tournament as well on Sept 30th.

A note on our Endowment team- we met with the Tompkin family about transferring the taking of applications and case work for Not Too Far From Here. The Endowment team will continue to manage those funds and send as the funds are available to assist those in need. Rising Hope is positioned much better for intake and in providing funding to those in need and helping beyond just a quick one-time aid. An MOU is in process of being worked on and agreed to by our Endowment

team and Rising Hope. Looking to transfer this by Oct 1, 2024.
