
# Aldersgate United Methodist Church Zoom Church Conference and Leadership Team Meeting

    - The engaged team recently sponsored the December caroling on the Corner event. Due to cold and damp weather, the event was moved indoors, but was well attended, and the music, scripture readings and joyful singing helped everyone continue to get into the Christmas spirit.

- EQUIP has updated the MAP ahead of the January summit.
- Send Mission & Service, Julie Pfister and Sandra Gehring
  - We met our goals for Rising Hope (RH) in October by contributing \$1,250 and over 1000 pounds of food. Also, we just donated an additional \$2,500 to meet the RH Food Market needs during the holiday season. Additionally, we have contributed hundreds of pounds of warm clothing to the hypothermia shelter.
  - Jill Cox reported on Be The Good that We finished the BTG mission with 40 boxes that have been delivered. Therefore, anything in the donation food area was donated to Rising Hope
  - Alternative Giving will continue through the end of the month. We have gotten some feedback regarding the new catalog. People are missing the animals and some of the items in the old catalog and some of the new items are unclear. Hoping to hear back from Cambodia UMM Helen Camarace.
  - Epiphany Tree Molly is heading
  - Rising Hope's new cook had to resign for medical reasons. We provided 4 meals for lunches. The new UWF women's circle Kiononia will also provide a couple meals.
  - Sandra and I spoke with a couple of the Moms at the Mom to Mom group about some SEND needs and we got a good response. SEND would like to reach out to other groups in person and talk about ministry area needs.
  - Karen Latta responded promptly to a call from the Kennedy Shelter about the need for hygiene items. We started a collection and will highlight hypothermia shelter for Jan mission focus. Karen reports that hypothermia project is going well. All volunteers are arranged for January, but we have an open slot on New Year's Eve. Meals for 24 guests.

- Day School Liaison Barb Roach
  - The Aldersgate Day School Evening with Santa sold out again this year and was bigger than ever. In addition to a home cooked meal served by their teachers. All of the families that came brought a toy for the Toys for Tots campaign.
  - This year, the Day School purchased a light up Crèche scene in silhouette which they are loaning to the church to use for our nativity animals area on Christmas Eve.
- 5. Church Work Operations
  - Finance Update Mark Easton
    - I am providing the following four key discussion points relating to our current financial status:
      - The November financial synopsis is attached. We ended the month of November with a positive net position, but will end the year in a negative position, relative to our planned budget. We have maintained the necessary cash liquidity to make our pay our talented staff and maintain our facilities, despite seasonal ebbs and flows. On the revenue side, non-pledged giving is significantly less than projected. This budget deficit (and related liquidity needs) has been offset by occasional use of Shepherd Hall funds, deferring apportionment commitments, and UNDER-executing our planned budget.
      - The status of our Stewardship Campaign, ably led by Mark Husband is: 137 pledges received and \$818,361.72 pledged. We are currently conducting a series of phone call and email follow-ups. Each of our church family who have pledged will be receiving a small book and thank you note from Pasto Randy, as a memento of our appreciation. We will be asking for inputs of Time and

Talents (to include occupational talents) in January.

- Shepherd Hall Refinancing: Our Refinancing sub-committee, ably led by Ed Little, has negotiated the terms of a new loan agreement with the Virginia UM Development Company (DEVCO). JD Driscoll supported the court action necessary last week, and Ed is finalizing the details and schedule for closing on our new loan—likely in January 2025. Included in my email is Ed's status update providing details on the status of our Refinancing plans.
- One key element related to our efforts to Refinance our current Shepherd Hall Mortgage debt involved the sale of Parsonage #2 in October. As approved by the Leadership team, Net proceeds of the sale have been applied directly to the principal that will need to be financed, resulting in a balance under \$1M. As a result of discussions within the financial health team, I would like to make the following motion relating to this transaction:
  - "That an appropriate accounting entry be made that essentially liquidates the balance of Operating funds (an internal liability) that have previously been taken from the Shepherd Hall capital accounts"
- – Mark Easton (Updates on Finances, Stewardship, and Mortgage Refinance)
  - DEVCO Refinancing Status
    - Five Trustees approved to sign Loan documents by Fairfax County Circuit Court Order on September13, 2024
    - Trustees approved are Mark Easton, Sean Vermillion, Dave Halladay, Steve Larkin, and Ed Little
    - Loan Commitment with Virginia United Methodist Development Company (DEVCO) signed on November 15, 2024
    - Draft DEVCO Settlement papers submitted to Aldersgate on December 10, 2024.
    - DEVCO Settlement attorney is Ashley Harris. Ed Little is Point of Contact.
    - JD Driscoll acting as our lawyer received the Fairfax County Circuit Court.
       Judge signed final order to encumber church property on December 13, 2024
    - Settlement Attorney has initiated actions to procure Title Insurance and Survey documents. Completion of these documents will most likely drive when settlement will occur. Settlement attorney estimates mid-January 2025 for settlement.
    - Atlantic Union Bank loan matures on February 14, 2025.
